STATEMENT OF CHANGES IN ACTIVITIES and SOURCES OF FINANCING *

In the 2019-2020 fiscal year, the District was awarded a Federal Grant providing commercial air service Revenue Guarantee totaling \$750 thousand. The District expects to recieve \$50 thousand in the 2020-2021 fiscal year and the rest over the next several years. The airfield lighting project began in the 2018-2019 fiscal year and the rest over the next several years. The airfield lighting in the 2019-2020 fiscal year. The District also began an Environmental Assessment related to a Runway Safety Area improvement project in the 2018-2019 fiscal year. Both projects have been split into phases and will span several years. The District will begin and complete various facility improvements to one of it's existing leased properties in order to fufil a new lease agreement effective June 9, 2019. A new loan of approximatley \$1.1 million will be needed to complete this work within the 2020-2021 fiscal year. Can proceeds in the 2019-2020 fiscal year. The District will begin and complete various facility refinancing of several existing leased to accomplete the work within the 2020-2021 fiscal year. The 2019-2020 fiscal year include the refinancing of several existing loans. The District will began construction of an ARFF facility and a Maintenance shop in the 2019-2020 fiscal year. These projects will be funded through a combination of State and Federal grants, as well as a sponsor match provided by the District.
